MATTHEW PHOTIS, being duly sworn, deposes and says:

1. I am a Claims Manager with Everest National Insurance Company and submit this affidavit in support of Everest Indemnity Insurance Company’s (“Everest”) Motion to Lift the Asset Freeze Order to Permit Payment of Defense Costs to date, and going forward, pursuant to the terms and conditions of the Everest Excess Liability Policy No.: FL5EE 00006-091 issued to Western International Securities for the policy period 3/1/09-3/1/10 (“Everest Policy”) (Exhibit “A” hereto).

2. I handle the Claims in connection with the instant motion under the Everest Policy. The Everest Policy covers the Named Insured, Western, its registered representatives and certain other entities and individuals as set forth in the Everest Policy definition of Insured.

To date, Everest has received notice under the Everest Policy with respect to the following matters:

- A) *United States Securities and Exchange Commission v. Jason Bo-Alan Beckman, et al.*, Case No. 11-cv-574 (MJD/FLN) filed in United States District Court District of Minnesota (“*SEC Action*”) (Exhibit “B” hereto);
- B) *Howard and Sharon Phillips, et al. v. Trevor Cook et al.*, Case No. 09-CV-1732 filed in the United States District Court District of Minnesota (“*Phillips Action*”) (Exhibit “C” hereto);
- C) *In the Matter of Arbitration of John and Lisa Sos and Western International Securities, Inc., Jason Bo-Beckman & NRP Financial, Inc.*, FINRA No. 09-05297 (“*Sos Arbitration*”) (Exhibit “D” hereto);
- D) *In the Matter of the Arbitration of Dale and Ann Woodbeck, et al. v. Jason Bo Beckman, NRP Financial, Inc. and Western International Securities, Inc.*, (“*Woodbeck Arbitration*”) (Exhibit “E” hereto);
- E) *In the Matter of Arbitration of Anne E. Quiggle, et al. v. Jason Bo Beckman, et al.*, (“*Quiggle Arbitration*”) (Exhibit “F” hereto);
- F) *In the Matter of Arbitration of Ralph R. Abrahamson v. Western International Securities, et al.* (“*Abrahamson Arbitration*”) (Exhibit “G” hereto);
- G) September 13, 2010 email from Matthew Boos, counsel for Paul Wood, advising of a claim or potential claim by Ronald Stolpman (“*Stolpman Claim*”) (Exhibit “H” hereto);
- H) SEC subpoenas issued to a) Beckman dated June 21, 2010; b) Oxford c/o Jason Beckman dated June 23, 2009 and c) Oxford Global Advisors c/o Jason Beckman dated June 22, 2009 (the “*Beckman Subpoenas*”) (Exhibit “I” hereto);
- I) SEC subpoena issued to Adam Edenberg (“*Edenberg Subpoena*”) (Exhibit “J” hereto);
- J) FBI investigation including an interview of Paul Wood (“*FBI Investigation*”). (Exhibit “K” hereto);
- K) *Gurvant Bhatt v. Western Instrument Services, Inc., NRP Financial, Inc. and Eric Erickson*, FINRA No. 11-01754 (“*Bhatt Arbitration*”) (Exhibit “L” hereto).

3. The Everest Policy provides excess coverage above that of a primary policy for the same policy period issued by Underwriters of Lloyds (“Underwriters Policy”) (Exhibit “M” hereto). On December 20, 2010, Everest received notification that the full limits of the Underwriters policy was exhausted. (Exhibit “N” hereto)

4. Following exhaustion of the limits of the Underwriters’ policy, Everest has been asked by its Insureds to defend the various Claims for which notice has been provided under the Everest Policy and pay Defense Costs pursuant to the terms and conditions of the Everest Policy.

5. To date, I have received invoices totaling \$230,545.54 from defense counsel for the Insureds and requests that such be paid. The law firms, their clients and the amounts requested are set forth on a spreadsheet annexed to this affidavit as Exhibit “O”.

6. I have reviewed those invoices and found them to be in compliance with the requirements of the Everest’s policy.

7. A number of Insureds, including Mr. Beckman remain as defendants in the Claims and have requested that Everest continue to provide a defense for the Claims under the terms and conditions of the Everest Policy.
