**MOTION TO AUTHORIZE SALE OF AND TRANSFER OF TITLE TO  
SPECIFIC ASSETS OF THE RECEIVERSHIP**

The Receiver, R. J. Zayed, hereby respectfully moves the Court for an Order authorizing the Receiver to sell and transfer title to specific assets of the Receivership as follows:

As set forth in the Court's Second Amended Order Appointing Receiver [Docket 68, No. 09-cv-3333] and Order Continuing Appointment of the Temporary Receiver [Docket 96, No. 09-cv-3332], the Receiver Estates include: (1) the estates of Defendants Trevor G. Cook ("Cook") and Patrick J. Kiley ("Kiley"), (2) Defendants UBS Diversified Growth LLC, Universal Brokerage FX Management, LLC, Oxford Global Advisors, LLC, and Oxford Global Partners, LLC (the "Defendant Shell Companies"), (3) Relief Defendants Basel Group, LLC, Crown Forex, LLC, Market Shot, LLC, PFG Coin and Bullion, Oxford Developers, S.A., Oxford FX Growth, L.P., Oxford Global Managed Futures Fund, UBS Diversified FX Advisors, LLC, UBS Diversified FX Growth L.P., and UBS Diversified FX Management, LLC (the "Relief Defendant Shell Companies"), (4) all funds, accounts, and other assets held by or for Relief Defendants Clifford Berg and Ellen Berg, which were received, directly or indirectly, from the Defendants or were acquired with funds or other assets received, directly or indirectly, from the Defendants, and (5) every other corporation, partnership, trust and/or other entity (regardless of form) which is directly or indirectly owned by or under the direct or indirect control of Cook or Kiley, or any individual working in concert with any of the Defendants.

Pursuant to this Court's Order Authorizing the Receiver to Seize Assets and Inspect Forthwith the Residence of Gina and Trevor Cook [Docket 189, No. 09-cv-3332; Docket 183. No. 09-cv-3333], the Receiver therefore respectfully moves this Court for an Order authorizing the Receiver to obtain, sell and transfer title to following Receivership assets: (1) 2004 Lexus LS 430 (VIN: JTHBN36F340162412) registered in the name of Graham Palmer Cook; (2) 1997 BMW 328ic (VIN: WBABK832XVEY85894) registered in the name of Market Shot LLC; and (3) 2005 Lexus R33 (VIN 2T2HA31U15C086611), registered in the name of Gina Lea Cook.

This motion is supported by an accompanying declaration of the Receiver and the exhibits thereto, arguments of counsel, the Proposed Order submitted herewith, and the files and proceedings herein.
